¹ Previous arrangement must be made with PAL Management and must be carried or shipped by a priest.

² Unless previous arrangements are made with PAL Management, written approval must be obtained from the local Community Chief and Council where the alcohol will be transported (regardless if the Community is wet or dry).

³ Items cannot be placed into baggage once they are removed during the boarding process.

⁴ Items may be shipped in the back of the airplane (cargo compartment) if weight/space is available.

⁵ Item is considered a dangerous good and must comply with Transportation of Dangerous Goods Regulations.
